



FA Charter Standard Club, Sport in the Heart of Rugby

MATCH DAY ACTION PLAN FOR HEALTH AND SAFETY

This plan should be used in conjunction with the clubs Risk Assessment and along with FA and Government ongoing guidelines to ensure the safety of all members of Rugby Town Girls & Women FC.

- 1. All volunteers to have a copy of the clubs following documents:
 - a. Risk Assessment (available online / in volunteer group files)
 - b. Emergency Action Plan (available in volunteer group files)
- 2. Spectators You are reminded that all social guidelines issues by ongoing government annoucments must be adhered to, e.g no large groups gathers, spectators to be spread out with spacing as equired, hand gel to be used on entry to buildings and respect to other people around the facility.
- 3. Pitch Entry Before accessing the pitch, team managers of their respective teams must be at the gate to hand sanitise every person entering. The home team is responsible for match or FA officials No other persons should be entering the match area
- 4. Mini Soccer Astro Top Pitch as 7 a side Spectators are not permitted inside the astro caged area
- 5. Mini Soccer Astro Top Pitch as 5 a side If desired, where half a pitch is used, barriers may be placed to allow spectators pitch side. Barriers must be 3 meters from the pitch sideline. Where no barriers are used, spectators are not permitted inside the astro caged area
- 6. Main Astro Pitch as 11 a side Spectators are not permitted inside the astro caged area
- 7. Main Astro Pitch as **9 a side** If desired, barriers may be placed to allow spectators pitch side. Barriers must be 3 meters from the pitch sideline. Where no barriers are used, spectators are not permitted inside the astro caged area
- 8. Washroom If open, they should always be kept cleaned by onsite persons responsible and have a regular cleaning plan displayed
- 9. Equipment Goals and balls should be wiped down with disinfection wipes or liquid before each game, and again at half time and full time. Balls should be wiped before throw ins.
- 10. Track and Trace Open Area Home and Away team managers wil be responsible for holding details of persons attending fixtures. Away teams manager will be the sole person of contact should the need arise who would hold details for their club traveling players. This is for GDPR and protection of all data
- 10 Track and Trace Enclosed Area For stadium entry, supporters will be required to register on entry

By attending Rugby Town Girls & Women FC Facility to play matches, the opposing team manager agrees to the above standard as representive of there own respective club, member and supporters, set out by Rugby Town Girls & Women FC for the health and safety of everyone.
